# सोमवार से होगी एक घंटा अतिरिक्त सुनवाई



शुक्रवार को राम जन्मभूमि-बाबरी से रोजाना एक घंटा अतिरिक्त सुनवाई करने का निर्णय किया है। एक घंटे का समय इसलिए बढ़ाया गया है ताकि अयोध्या मामले की सुनवाई 18 अक्टूबर तक पूरी की जा सके। प्रधान न्यायाधीश (सीजेआई) रंजन गोगोई की अध्यक्षता वाली पांच सदस्यीय संविधान पीठ ने इस विवाद के दोनों पक्षों के वकीलों से कहा कि उसने सामान्य प्रक्रिया के तहत शाम चार बजे की बजाय रोजाना पांच बजे उठने का निर्णय लिया है। संविधान पीठ के अन्य सदस्यों में न्यायमुर्ति एसए बोबडे, न्यायमूर्ति धन्नजयं वाई चन्द्रचूड़, न्यायमूर्ति अशोक भूषण और न्यायमूर्ति एस अब्दल नजीर शामिल हैं। संविधान पीठ अयोध्या में विवादित 2.77 एक-ड भिम सन्नी वक्फ बोर्ड, निमोहीं अखाँडा और राम लला के बीच बराबर बराबर बांटने संबंधी इलाहाबाद उच्च न्यायालय के सितंबर 2010 के फैसले

#### 'जम्म्-कश्मीर में लोगों की हाईकोर्ट से संपर्क करने में असमर्थता संबंधी दावा सही नहीं'

सुप्रीम कोर्ट ने आज जम्मू और कश्मीर में अनुच्छेद 370 के प्रावधानों को खत्म किए जाने सें जुड़े कई मामलों में सुनवाई की। सुप्रीम कोर्ट ने शुक्रवार को कहा कि उसे उच्च न्यायालय के मुख्य न्यायाधीश से रिपोर्ट मिली है जो जम्मू-कश्मीर में लोगों के हाईकोर्ट से संपर्क करने में असमर्थ होने संबंधी दावे का समर्थन नहीं करती। कश्मीर में बच्चों को कथित तौर पर हिरासत में रखे जाने का आरोप लगाने वाले बाल अधिकार कार्यकर्ता इनाक्षी गांगुली और शांता सिन्हा की ओर से पेश वरिष्ठ अधिवक्ता हुजेफा अहमदी ने 16 सितंबर को शीर्ष अदालत को बताया था कि घाटी के लोग वहां हाईकोर्ट से संपर्क नहीं साध पा रहे हैं। इसके बाद पीठ ने जम्मू–कश्मीर के मुख्य न्यायाधीश से इस बारे में रिपोर्ट मांगी थी।

पीठ ने इस प्रकरण के हिन्दू और मुस्लिम पक्षकारों के वकीलों से कहा, 'हम सोमवार (23 सितंबर) से एक घंटा अतिरिक्त बैठ सकते हैं। शीर्ष अदालत ने इस प्रकरण की सुनवाई 18 अक्टूबर तक पूरी करने का निश्चय किया है ताकि उसे करीब चार सप्ताह

के खिलाफ दायर अपीलों पर छह का समय फैसला लिखने के लिए अगस्त से रोजाना सुनवाई कर रही है। मिल जाए। न्यायालय का यह निर्णय इसलिए महत्वपर्ण है क्योंकि प्रधान न्यायाधीश रंजन गोगोई 17 नवंबर को सेवानिवृत्त हो रहे हैं। ऐसी स्थिति में 130 साल से भी अधिक पुराने इस विवाद में नवंबर के मध्य तक शीर्ष अदालत का सिवचारित निर्णय आ जाने की उम्मीद है।

### रोहित वेमूला और पायल तडवी मामले में केंद्र को भेजा नोटिस

उच्चतम न्यायलय ने शुक्रवार को एक जनहित याचिका पर सुनवाई की। जिसे रोहित वेमूला और पायल तडवी की मां ने दायर किया था। याचिका में उन्होंने केंद्र और विश्वविद्यालय अनुदान आयोग (यूजीसी) को देशभर के उच्च शिक्षण संस्थानों और विश्वविद्यालयों में होने वाले जाति आधारित भेदभाव को लेकर दिशा-निर्देश जारी करने की मांग की गई। अदालत ने इसपर केंद्र सरकार को नोटिस भेजकर जवाब मांगा है। वेमला और तड़वी ने जाति आधारित भेदभाव होने की वजह से कथित तौर पर आत्महत्या कर ली थीं। जहां वेमूला हैदराबाद केंद्रीय विश्वविद्यालय में पीएचडी का छात्र था। वहीं तडवी टीएन टोपीवाला नेशनल मेडिकल कॉलेज में स्त्री रोग विशेषज्ञ की परास्नातक की पढ़ाई कर रही थीं। रोहित ने 17 जनवरी, 2016 को और पायल ने इसी साल २२ मई को आत्महत्या की थी क्योंकि कॉलेज में तीन डॉक्टर उसके साथ आदिवासी छात्रा होने के कारण जातिसूचक शब्दों का इस्तेमाल करती थीं। न्यायमूर्ति एनवी रमन्ना और अजय रस्तोगी की पीठ ने यांचिका पर केंद्र को नोटिस भेजकर उससे चार हफ्तों के अंदर जवाब दाखिल करने को कहा है। दोनों मांओं के लिए वरिष्ठ वकील इंदिरा जयसिंह पेश हुईं। उन्होंने अदालत से कहा कि यूजीसी के नियम हैं लेकिन उन्हें लागू नहीं किया जा रहा है।




