शिमला। ऊना जिले के पेखुवेला में शराब पकड़ने गई पुलिस की एसआईयू टीम पर हमला किया गया है। शराब से भरी गाड़ी पकड़ने के बाद पुलिस टीम के दो सदस्यों के साथ जमकर मारपीट हुई। पुलिस कर्मियों के साथ मारपीट करने वालों में ऊना सदर से कांग्रेस विधायक सतपाल रायजादा के पीएसओ और ड्राइवर भी शामिल हैं और पुलिस ने इन्हें भी गिरफ्तार किया है। साथ ही शराब वाली गाड़ी के चालक को भी पुलिस ने जब्त कर लिया है। यही नहीं, पुलिस ने विधायक की गाडी को भी कब्जे में ले लिया है। बताते हैं कि घटना के वक्त गाड़ी में विधायक सतपाल रायजादा सवार नहीं थे। पुलिस के मुताबिक एसआईय की
