





जोकोविच ने मीडिया से बात नहीं की, लेकिन कुछ घंटे बाद उन्होंने अपनी तरफ से माफीनामा जारी किया। जोकोविच ने लिखा, 'इस पूरी स्थिति से मैं वास्तव में बेहद दुखी हूं। मैंने लाइन अंपायर के बारे में पता किया और टूर्नामेंट के अधिकारियों ने मुझे बताया कि वह अच्छा महसूस कर रही हैं। मझे उन्हें इस तरह तनाव की स्थिति में डालने पर खेद है। मैंने जानबुझकर ऐसा नहीं किया। यह गलत था।

विजय अभियान थम गया और उनका 18वां ग्रैंडस्लैम खिताब जीतने का सपना भी टूट जोकोविच का गया। आर्थर ऐस स्टेडियम में चल रहे मैच में विश्व के नंबर एक १८वां ग्रैंडस्लैम खिताब जीतने का खिलाडी और खिताब के प्रबल सपना भी टूटा दावेदार जोकोविच उस समय
