यूएस ओपन

29 मैचों से चला आ रहा विजय अभियान थमा

नोवाक जोकोविच को रविवार को यहां अपने चौथे दौर के मैच के दौरान 'लाइन जज' के गले पर गलती से टेनिस बॉल मारने के कारण यूएस ओपन टेनिस टूर्नामेंट से बाहर कर दिया गया जिससे उनका 29 मैचों से चला आ रहा विजय अभियान थम गया और उनका 18वां ग्रैंडस्लेम खिताब जीतने का सपना भी टूट गया। आर्थर एस स्टेडियम में चल रहे मैच में विश्व के नंबर एक खिलाड़ी और खिताब के प्रबल दावेदार जोकोविच उस समय पाब्लो कारेनो बस्टा से पहले सेट में

6-5 से पीछे चल रहे थे जब उन्होंने गुस्से में बेसलाइन से अपने पीछे गंद मारी। गेंद सीधे महिला लाइन जज के गर्दन पर लगी जो उस समय घुटने मोड़कर खड़ी थी। इसके बाद नेट के करीब चेयर अंपायर ऑरिली ट्रूटे, टूर्नामेंट रेफरी सोरेन फ्रीमेल और ग्रैंडस्लेम पर्यवेक्षक आंद्रियास इगली के बीच 10 मिनट तक चली चर्चा के दौरान जोकोविच को माफी मांगते हुए देखा गया। मैच के बारे में फैसला करने वाले फ्रीमेल ने कहा, "उसका कहना था कि उसने जानबूझकर लाइन अंपायर पर गेंद नहीं मारी। उसने कहा कि 'हां मैं गुस्से में था, मैंने गेंद हिट की। मैंने गेंद लाइन अंपायर पर मारी। सच्चाई सामने है लेकिन मेरा इरादा ऐसा नहीं था। मैंने जानबूझकर ऐसा नहीं किया।" इसलिए उसका कहना था कि उसे इसकी सजा नहीं दी जानी चाहिए।"

'लाइन जज' पर जोकोविच ने गलती से मारी गेंद माफी मांगने के बावजूद टूर्नामेंट से किया बाहर



जोकोविच ने जारी किया माफीनामा

जोकोविच ने मीडिया से बात नहीं की, लेकिन कुछ घंटे बाद उन्होंने अपनी तरफ से माफीनामा जारी किया। जोकोविच ने लिखा, 'इस पूरी स्थिति से मैं वास्तव में बेहद दुखी हूँ। मैंने लाइन अंपायर के बारे में पता किया और टूर्नामेंट के अधिकारियों ने मुझे बताया कि वह अच्छा महसूस कर रही है। मुझे उन्हें इस तरह तनाव की स्थिति में डालने पर खेद है। मैंने जानबूझकर ऐसा नहीं किया। यह गलत था।'

दोषी पाए गए जोकोविच : अमेरिकी टेनिस संघ

अमेरिकी टेनिस संघ (यूएसटीए) ने हालांकि बयान जारी करके कहा कि फ्रीमेल ने जोकोविच को दोषी पाया। बयान के अनुसार, 'ग्रेडस्लेम नियमों के अनुसार उनकी हरकत गेंद को जानबूझकर खतरनाक तरीके या कोर्ट के अंदर लापरवाही से मारने के अंतर्गत आता है। यूएसटीए ने कहा कि जोकोविच ने टूर्नामेंट से मिले रैंकिंग अंक और 2,50,000 डॉलर की पुरस्कार राशि उन्हें नहीं दी जाएगी।

गलती पर किया निष्कासित

फ्रीमेल ने कहा, 'हां हम भी सहमत थे कि उसने जानबूझकर ऐसा नहीं किया लेकिन यह साफ था कि उसने लाइन अंपायर पर गेंद मारी जिससे वह घायल हो गई थी।' जोकोविच आखिर में कारेनो बस्टा से हाथ मिलाने के लिए चले गए। ट्रूटे ने इसके बाद घोषणा की कि जोकोविच ने गलती की है और इसलिए उन्हें निष्कासित कर दिया गया है।

इससे पहले भी खिलाड़ी हुए बाहर

इससे पहले भी गुस्से में गेंद पर मारने के लिए खिलाड़ियों को बाहर कर दिया गया था। कनाडा के डेनिस शापोवालोव को 2017 में ब्रिटेन के खिलाफ अपना डेविस् कप मैच गंवाना पड़ा था। उन्होंने गलती से चेयर अंपायर के चेहरे पर गेंद मार दी थी। विंबलडन 1995 में टिम हेनमैन ने युगल मैच के दौरान 'बॉल गर्ल' के सिर पर गेंद मार दी थी और उन्हें मैच गंवाना पड़ा था।
