का सदस्य बनवां दिया था। चौधरी तैय्यब हसैन की प्रतिभा से आकर्षित होकर मुख्यमंत्री सरदार प्रताप सिंह कैरों ने उन्हें अपने मंत्रिमंडल में शामिल कर लिया था। यह भूमिका उनहोंने दक्षता के साथ निभाई थी। किंतु 1964 में करो के स्थान पर बने मुख्यमंत्री कामरेंड राम किशन ने उन्हें मंत्री नहीं बनाया था पर 1 नवंबर 1966 के दिन हरियाणा का गठन होने के बाद राज्य के पहले मख्यमंत्री पं. भगवत दयाल शर्मा ने उन्हें मंत्रिमंडल में फिर से जगह दे दी थी। 1967 में उन्हें हरियाणा सरकार के द्वारा पंजाब वक्फ बोर्ड का अध्यक्ष बनाया गया। 1971 में चौ. तैय्यब हुसैन गुड़गांव क्षेत्र से कांग्रेस के प्रत्याशी के रूप में लोकसभा के सदस्य चूने गए। 1980 में इसी के टिकट पर फरीदाबाद क्षेंत्र से दूसरी बार लोकसभा के सदस्य बने थे। 1993 से 1998 तक चौ. तैय्यब हुसैन कयान (भरतपुर) चुनाव क्षेत्र से राजस्थान विधानसभा के सदस्य चुने गए और उस राज्य के मंत्रिमंडल में

शामिल किए गए थे। गौरतलब है कि राजस्थान के अलवर और भरतपुर जिले मेवात क्षेत्र का भाग है और चौधरी यासीन खान की मृत्यु के बाद मेवात का चौधरी घोषित किए जाने के कारण उनका राजस्थान के मेवाती क्षेत्र में भी काफी प्रभाव था। इसका प्रभाव यह है कि उनकी पत्री जायदा खान भी उनके स्थान पर राजस्थान विधानसभा का सदस्य चनी गई थी। जैसा कि संयुक्त राज्य अमेरिका की यूनिवसिटीं के प्रसिद्ध राजनीतिक शास्त्री प्रो पालवालेस ने लिखा है एक लंबी अवधि तक मेवात क्षेत्र में राजनीतिक संघर्ष चौ. तैय्यब हुसैन और उनके प्रतिद्धंद्वी चौ. तैय्यब हुसैन के बेटे जाकिर हुसैन का इंडियन नेशनल लोकदल का सदस्य के टिकट 2014 में विधायक चुने जाने से और चौधरी खुरशीद अहमद के भतीजे चौ. आफताब अहमद के 2019 में विधायक चुने जाने से पता लगता है। मेवात क्षेत्र के इस महान नेता का ७ अक्तूबर २००८ के दिन स्वर्गवास होने से एक प्रकार से राजनीति के उस युग का अंत हो गया जो कि 1962 में शुरू हुआ था। चौ. तैय्यब हुसैन ने न केवल मेव जाति के सामाजिक सांस्कृतिक और आर्थिक विकास के लिए एक लंबी अवधि तक प्रयास किया, मेवात क्षेत्र ने सांप्रदायिक सदभाव बनाये रखने के भी भरसक प्रयास किए और यहां 1993 में बाबरी मसजिद गिराये जाने के बाद सांप्रदायिक दंगे नहीं होने दिए। मेवात के शैक्षणिक विकास के लिए वह निरंतर प्रयास करते रहे और उन्होंने इसी उद्देश्य से नूंह में चौ. यासीन खान मेमोरियल कालेज की स्थापना भी की थी। मेवात को अलग जिला बनाने के लिए भी वे निरंतर प्रयास करते रहे थे और इस दिशा में सफल भी हो गए थे लेकिन बाद में हरियाणा सरकार ने मेवात का नाम बदलकर जिला नूंह कर दिया था क्योंकि एक तो यह नाम एक जाति विशेष से जुड़ जाता था। दूसरे मेवात क्षेत्र तो हरियाणा के फरीदाबाद, जैसे कि पहले बदलाया जा चुका है, राजस्थान के भरतपुर और अलवर जिलों तक फैला हुआ है। बहरहाल हम इस निष्कर्ष पर निसंकोच पहुंच सकते हैं कि चौ. तैय्यब हुसैन हरियाणा और राजस्थान के मेवात क्षेत्रों के एक ऐसे नेता थे जिन की मृत्यु से खाली हुआ स्थान कोई दूसरा नहीं ले सकता। वे एक महान नेता हीं नहीं बल्कि बहुत ही अच्छे इंसान थे। उनके संपर्क में जो भी आया उनसे प्रभावित हुए बिना नहीं रह सका। इस लेख के लेखक को भी 1967 में पंजाब वक्फ बोर्ड के कार्यालय अंबाला छावनी में और गुड़गांव में उनके निवास स्थान पर 1972 में मिलने का अवसर मिला था। उनकी बातों में कोई लाग-लपेट व फर्जीपन बिल्कल नहीं था। वे स्पष्टवादी थे
